I. Membership Details (Full details, please refer to Constitutions)

1) Associate Member- Individual – AMHKIUS (助理管綫專業監理員)

Membership is open to all persons who is working in the utility survey industry. All Associate Members shall be entitled to participate in all activities organized by the Institute but have no voting rights.

- Annual Subscription: \$500

2) Operative Member- Individual – OMHKIUS (管綫專業監理員)

Membership is open to all persons who have worked in the utility survey industry for at least 3 years. All Operative Member shall be entitled as Full Member and be granted rights to attend, elect, be elected, propose and vote at all activities.

Annual Subscription: \$800

3) Manager Member- Individual – MHKIUS (管綫專業監理師)

Membership is open to all persons who have obtained an accredited / recognized Degree or the equivalent and has been a full member of HKIUS for at least 5 years or a full member with at least 10 years relevant working experience. All Manager Member are entitled as Full Member and be granted rights to attend, elect, be elected, propose and vote at all activities.

Annual Subscription: \$1,000

4) Fellow Member- Individual – FHKIUS (管綫專業監理師(院士))

Membership is open to all persons who have obtained accredited / recognized Degree or the equivalent and is working in the utility survey industry at least 8 years or as a non-degree Manager Member for at least 8 years plus at least 15 years of relevant working experiences. All Fellow Member are entitled as Full Member and be granted rights to attend, elect, be elected, propose and vote at all activities.

Annual Subscription: \$1,200

5) Recognized Professional Utility Specialist (RPUS) (管綫專業監察師)

Candidates for election to the class of Recognized Professional Utility Specialist shall satisify the council who are eligible or have been an Individual Corporate (Professional) Member of HKIUS and have been working in Hong Kong for the utility related industry for not less than 2 years.

RPUS (apart from those also as Individual Corporate Members) are NOT Voting Members, and those who have paid the entrance fee and the annual subscription and shall be obliged to attend, but shall not be entitled to elect, accept election, propose and vote at all activities organized by the Institute Annual Subscription: \$1,200

6) Hon. Fellow- Individual – Hon. FHKIUS (By Invitation Only) (榮譽院士)

A person who hold a senior position and made a significant contribution to the knowledge and practice of utility survey. All Honorary Fellow Members shall not have the right to elect or to be elected in all activities.

7) Corporate Company Member – CCMHKIUS (公司會員)

Membership is available to all organization related to utility industry for 3 years or above. All Corporate Company Members shall have rights to attend, elect, be elected, propose and vote at all activities. Annual Subscription: Group A (3 member in the same discipline) \$3,000/ Group B \$5,000 (6 member in the same discipline)/ Group C (10 member in the same discipline) \$10,000

8) Sponsor Company Member – SCMHKIUS (贊助公司會員)

Be supportive to the utility survey industry. Annual Subscription: \$3,000

9) Overseas Members - Individual & Company (海外會員-個人及公司)

The annual subscription fees for Company and Individual Members are \$300 on top of the Local Members for postage and others

Basic requirements

The application will be processed based on the following criteria:

1. Education

(a) Operative Grade: Min DSE; or

(b) Manager Grade: Degree (Science, Surveying, Engineering)

2. Training

(a) a min of 84 hours structured training relevant to the discipline applied and conducted by **Registered or Recognized Training Organization (RTO) of HKIUS, namely, CIC, recognized universities (such as PolyU, including SPEED), IVE, UTI or Build.IT or all local institutes registered with statutory authority.

(b) if the above item 2(a) cannot be provided, trade test is required by a payment of HKD5,000 each time of test per discipline until pass.

**CIC = Construction Industry Council

UTI = Utility Training Institute

Build.IT = Build.IT Limited

3. Experience

(a) Operative Grade: Min. of 3 years; or

(b) Manager Grade: 5 years

4. Safety training

- CSW is a min for Location and Condition trades, or, 10 hours safety related CPD annually for Management trades

5. Professional CPD^ (Past 2 years - 1 Jan to 31 Dec prior to application):

- min of 35 hours annually (10 hrs related to safety); or, 70 hours in 2 years before application (20 hrs related to safety)

^We accept CPD training conducted by any of our *Registered or Recognized Training Organization (RTO), namely, CIC, recognized universities (such as PolyU, including SPEED), IVE, UTI or Build.IT or all local institutes registered with statutory authority and also recognized professional institutions (such as CIC, HKIE etc)

6. Professional assessments

- 3 written papers and one interview.

Remark: All applications for membership are personal data, HKIUS will not disclose any details to others either by email, fax or in person unless they are authorized by letter.
